**CITIZENS' OVERSIGHT COMMITTEE ■ MEASURE V BOND**

**SCOPE OF RESPONSIBILITIES**

- Purpose:** To actively review and report to the public on the proper expenditure of taxpayers' money for school construction and to ensure that Measure V bond proceeds are spent only for the purposes described in the School Facilities Plan as presented to voters at the time of the election.
- Goal:** To validate to the community that the William S. Hart Union High School District is in compliance with the requirements of the "Smaller Classes, Safer Schools and Financial Accountability Act" (Proposition 39) in that all general obligation bond proceeds are expended in accordance with the bond measure (Measure V) as approved by voters.
- Terms and Conditions:** Individual members of the Citizens' Oversight Committee will serve for a term of two years without compensation and for no more than two consecutive terms. Committee members appointed to fill a vacancy will serve for the remainder of the unexpired term of the vacating committee member.
